






### What is EvoNotify?


## EvoNotify, use it to raise alerts or log inspections in our Evo solutions or to your own back office risk software solutions

- Policy, and compliance and risk assessment document distribution






# Accident, incident or near miss notification

On demand easy to use capability to log incidents, accidents and never miss, a near miss.

Quick, two-step easy to use mobile capability to log real-time near misses, incidents or accidents using a simple guided form, categorised correctly, upload your pictures, videos and auto track your location.

EvoNotify ensures your log is accurate, reportable, auditable and trackable in trends.






#### Claim notification

Easy, accurate notification of claim loss.

Log the claim loss, categorised correctly via our easy to use selections and guided for ease of use. Also upload pictures, videos of the loss and track your location.

On demand mobile claim notification ensures nothing is missed and reduces claim processing time if incorrect information was originally submitted by the claimant.





#### **Audit / Inspection**

Guided audit and inspection questions online or offline

For use by anyone at anytime. Our self-audit feature can also be used by third party auditors. Guided question sets focus on identifying defects, setting key actions to resolve (manually via the app or automatic workflow) and uploading evidence of pictures, video with built in location tracking along with online or offline capability (in case there is no mobile signal.)

Mobile audit frees up your paper based report and decreases the time to complete but most importantly keeps you diligent and compliant with follow up key actions of resolution.





### **Crisis Response**
